



#### BELGRADE NIKOLA TESLA AIRPORT



Belgrade Nikola Tesla Airport or Belgrade Airport is an international airport serving Belgrade, Serbia. It is the largest and the busiest airport in Serbia, situated 18 km west of downtown Belgrade. Numerous global flag carriers - Emirates, Turkish Airlines, KLM, Swiss, Air France. Air Serbia and Lufthansa operates to this airport. Some delegates and especially those from USA/Canada, Asia and those whose own preferred carrier does not fly into Belgrade may consider flying via Germany or Switzerland, Dubai, Istanbul or Qatar. Connections from those countries are pretty frequent and convenient.





#### TAXI SERVICE

Transportation from the Belgrade airport to the hotel is the easiest by taxi – this is especially the case if you are travelling with a lot of luggage. It takes about 35 minutes by car depending on the traffic. Various taxi and limo agencies including Car go – similar to UBER (app can be easily downloaded) operate between the airport and Belgrade downtown, and the price is calculated by taximeter (it should be around EUR 25).

#### **CONFERENCE TERMS AND CONDITIONS**

Non-members may attend the IAIR conference only by invitation or agreement of the IAIR Executive Committee.

We welcome people who would be eligible to be members, to come along to and attend our conference as a non-member to help them to learn more about our association before joining.

If you are thinking about joining IAIR this may be an ideal opportunity for you to learn more about us and what benefits membership could bring you. However, to be eligible to be an IAIR member you must be a government employed national insolvency representative from a Government Department, Ministry, Agency or Public Authority which has responsibility in their country for one or more of:

- Insolvency Policy and Legislation
- Insolvency Practice and Administration
- Insolvency Regulation
- Delegate/Registration Fee

The conference registration/delegate fee covers three days attendance at the conference, conference refreshments and lunches, the welcome reception, the formal dinner and the informal dinner. Please note it does not include your accommodation which you must book directly yourself and arrange payment directly with the hotel.
