

Divertimento Restaurant

Bruno Sacco, a civil engineer by profession, after working for more than ten years in Rome, at the United Nations World Food Programme, evaluating projects in developing countries, decided to return to his native Chile and open a restaurant. Italian food. This is how he delighted the people of Santiago in his “The Divine Food”. At the same time, as vice president of the Chilean Gastronomy Association, Achiga, he was in charge of organizing and carrying out cooking competitions in Chile, aimed at professional chefs in restaurants and hotels.

At the beginning of the nineties they decided to organize a national contest, this time aimed at housewives, with the aim of rescuing the tradition of Chilean cuisine.

Pleasantly surprised by the quantity and variety of delicious dishes that came to light thanks to the contest and, observing that in Santiago there were few good places offering Chilean cuisine, he decided in 1991 to open Divertimento Chileno with dishes of extensive local roots.



In preparation for your participation in the 2025 IAIR Annual Conference and General Assembly, we have prepared the following guide with useful information to help you enjoy your stay, travel, and overall experience during your visit.



Language

Though the conference will be in English, the official language in Chile is Spanish. In hotels, shopping centers, and tourist areas, it is common to find people who speak English, although it is recommended to know some basic Spanish phrases to ease daily interactions.



Location and Surroundings

The Conference will take place at the NH Collection Plaza Santiago Hotel, located at Av. Vitacura 2610, in the Las Condes district—one of the city’s most modern, safe, and well-connected areas. The hotel is located directly across from the Costanera Center, the largest shopping mall in South America, and just steps from the Tobalaba Metro Station. Nearby services and attractions include:

- Costanera Center: shops, supermarket, pharmacy, currency exchange offices, restaurants.
- Sky Costanera: the tallest observation deck in Latin America.
- Isidora Goyenechea and El Golf: gourmet dining and boutique shopping.
- Metropolitan Park and San Cristóbal Hill: panoramic views and green areas.



Transportation and Mobility

Santiago Metro:

- Tobalaba Station (Lines 1 and 4) is a short walk from the hotel.
- A Bip! card is required for metro and bus access.
- Fares: between CLP \$710 and \$870 (metro), CLP \$770 (bus).

Taxis and Airport Transportation:

- Avoid informal offers. Use official taxis or apps such as Uber or Cabify.



Electricity and Connectivity


Voltage: 220V / 50Hz. Plug types: C and L. We recommend bringing a universal adapter if your devices use a different plug type. The hotel offers Wi-Fi access throughout the premises.



Safety Recommendations


Santiago is a safe city, but we recommend:

- Keep your belongings secure in crowded areas.
- Avoid displaying high-value items in public.
- Use authorized transportation services.




Currency and Financial Services

The local currency is the Chilean peso (CLP). Foreign currency can be exchanged at currency exchange offices, or you can withdraw cash from ATMs. International cards are widely accepted. A 10% tip is customary in restaurants.



Drinking Water and Health

Tap water is safe to drink. For medical attention, Clínica Alemana is located a few minutes from the hotel. Pharmacies and medical centers are also nearby.

- Historic city center: Plaza de Armas, Cathedral, Museums
- Museum of Memory and Human Rights

Conference Attendance

Non-members may attend the IAIR conference only by invitation and agreement of the IAIR Executive Committee.

We welcome delegates who would be eligible to be members to come along to and attend our conference as a non-member to help them to learn more about our association before joining. This is an ideal opportunity for non-members to learn more about IAIR and what benefits membership can bring. However, to be eligible to be an IAIR member you must be a government employed national insolvency representative from a Government Department, Ministry, Agency or Public Authority that has responsibility in their country for one or more of:

- Insolvency Policy and Legislation
- Insolvency Practice and Administration
- Insolvency Regulation

When an invitation is offered to a non-member, it is on the basis that the non-member will:

- Only be able to bring a maximum of 4 delegates per potential member organization.
- Provide the full list of all delegates they intend to send, ideally at the same stage as requesting permission to attend, and no later than the date of receipt of the first request for registration.
- Accept one invoice generated to cover their organization's delegates and make the payment to the IAIR bank account as one payment.

Members will generally only be able to bring a maximum of 5 delegates to the conference. There may be exceptions to this in the case of the host country who may have more staff involved in the event, or if the Executive Committee agrees that there are exceptional circumstances.

The conference registration/delegate fee covers three days' attendance at the conference, conference refreshments and lunches, the tour on Monday, the welcome reception, the formal dinner and the informal dinner. Please note it does not include your accommodation, which you must book directly yourself and arrange payment directly with the hotel.

The closing date for registration will be 5 or 6 weeks before the date of the conference, at a date as determined by the host and their contracts with the conference venues. This closing date for registration will be clearly included on the conference registration forms.

The basis of the conference is that delegates learn from each other and hence delegates are expected to generally attend all sessions and be willing to participate in the workshops and group discussions.

2025 Delegate /Registration Fees:

IAIR Member Registration Fee £625
Non-Member Registration Fee £975
Accompanying Person Fee £300

Only IAIR members may attend and participate in the Annual General Meeting.

IAIR member delegate fees have to be paid and received by IAIR in its bank account two weeks before the conference commences to enable IAIR to pay the venues.

Non-members delegate fees and accompanying person fees have to be paid and received by IAIR in its bank account before the closing date for registration, as at that date IAIR is committed to the number of delegates and accompanying persons at the venues.

Accompanying Person

The accompanying person registration fee covers attendance on the tour, the welcome reception, the formal dinner and the informal dinner. Registered accompanying persons attending the social functions must be aged 21 or over and are defined as a participant's spouse or other personal relation who does not have a business interest in the conference. An accompanying person does not have access to the conference. Please note the fee does not include your accommodation, which you must book directly yourself and arrange payment directly with the hotel.

Dietary or Mobility or other Requirements

The registration form asks you to provide details of any special dietary or mobility requirements/access that you need for the event. We try to accommodate all such requests, but we do need advanced warning to make arrangements with the venues. Failure to record any such requests on the registration form may mean that we are unable to meet your needs adequately. The organising team will be in contact with you if we anticipate a problem in meeting any of your needs.

Conference Language

The IAIR conference is in English, and there are no translation facilities provided. Whilst those who are not fluent in English may wish to bring a colleague to help with some translation, this colleague will also be counted as a delegate and will need to be registered accordingly. Whilst this person can help with translation in some situations, delegates need to recognise that having somebody constantly translating for a colleague can be disruptive to those seated nearby and hence is not workable.

A lot of the work of the conference is undertaken in workshops and if you struggle with English you may find these sessions more challenging.

Payment & Refunds

Please note that your conference registration will only be confirmed in writing when full payment has been received and processed. Where a delegate cancels, individual circumstances are always considered. Normally the following refund and cancellation policy applies:

Cancel prior to the closing date for registration for the conference – 75% refund
Cancel after the closing date for registration of the conference – no refund issued as the host country will have committed to your place with the conference venues.

The appropriate refunds will be made after the conference has taken place. Delegate substitutions within organisations are permitted. Substitutions may be made at no charge up until 10 days before the conference. However, substitutions after the closing date for registration may have to accept menu choices etc. as chosen by the previous delegate if such details have already been provided to the venues.

Delegate Information

IAIR takes your privacy seriously. We will retain and use your personal data to provide you with information on our services. Your name, job title, organisation name, country and email address will only be distributed to fellow conference delegates.

Conference Papers and Discussions

To do our part to save the earth we will provide the conference papers:

- In advance of the conference on the member's area of the IAIR website.
- Saved as files on a memory stick provided to delegates in their delegate pack at the conference registration.

The conference papers are not available as a paper copy.

After the conference, IAIR members are welcome to share the conference papers and discussions with their colleagues in their own organisations. However, sharing discussions and any papers from the conference with a wider audience is not permitted without the explicit approval of IAIR and all of the authors of the papers. A key feature of the conference is that IAIR provides a "safe space" for regulators to share experiences and test developing ideas, strategies and legislation that is not always designed for a wider audience. This is one of the main reasons why IAIR restricts attendance at the IAIR conference to those eligible for IAIR membership or key partners.

Travel and Health Insurance

Delegates and accompanying persons are reminded that it is their responsibility to arrange travel and health insurance for the duration of their visit to the conference. IAIR shall not be responsible for, and shall be exempt from, all liability in respect of any loss, damage, injury, accident, delay or inconvenience to any person during the conference. Delegates are advised to check the travel requirements of all countries they will depart from and enter during their journey to and from Chile.

IAIR will be undertaking every precaution to ensure the health and safety of delegates during the conference. The Executive Committee requests that all delegates comply with any special precautionary measures that may need to be implemented to ensure the health and wellbeing of all delegates. Full details of any such requirements will be provided to delegates in advance of the conference.

Visa requirements

As is normally the situation for our conference, many delegates may require a VISA to enter Chile.

Foreign nationals who require prior authorization or a visa to enter the country must apply to the Ministry of Foreign Affairs through the consular representations of Chile abroad (Art. 169 of Law No. 21.325/2021).

Whilst the host team can help with letters of invitation and a Chilean-based contact to use on any application, it is the delegates' responsibility to arrange their visa requirements in a timely manner. Refunds will not be able to be provided, outside of the above refunds policy, to anybody who fails to attend the conference due to visa or immigration issues.

Social Events

As with previous years, the conference organisers have arranged an afternoon tour, a drinks reception, a formal dinner and an informal dinner for conference delegates.
